

**“Review AttiCat® Insulation for a Chance to WIN!”  
CONTEST OFFICIAL RULES**

**1. To Enter.** Beginning 12:00.00 p.m. EST on October 1, 2019 through 11:59.59 p.m. EST on June 30, 2020 (the "Contest Period"), visit [www.reviewatticatandwin.ca](http://www.reviewatticatandwin.ca) to submit a product review (the "Site") to enter the “Review AttiCat® Insulation for a Chance to WIN” Contest (the “Contest”) monthly prize. All potential winners will be contacted by a representative of Owens Corning Canada LP (“Sponsor”) via the email address provided on the entry form and are subject to verification. Potential winners will be required to correctly answer a time-limited skill testing question in order to be eligible to receive a prize. If the question is answered incorrectly, the prize will be forfeited. No review/purchase necessary. **2. Limit:** Each entrant may enter one (1) time only during the Contest Period, and the entry will be valid for the month the review was placed. Sponsor is not responsible for technical, hardware or software malfunctions, lost or unavailable network connections, or failed, incorrect, inaccurate, incomplete, lost, late, misdirected, illegible, mutilated, garbled or delayed entries or other communications or other technical problems related to online entries. The use of scripts, programs or an automated system to enter is strictly prohibited. Sponsor, in its sole discretion, reserves the right to disqualify any person who tampers with the entry process or the operation of the Site, or who otherwise violates these rules. By entering, entrants accept and agree to abide by the terms of these Official Rules.

**1. Eligibility.** This Contest is only open to permanent lawful residents of Canada, excluding Quebec, who have reached the age of majority in their province at the time of entry. The selected potential winner will be contacted by a representative of the Sponsor using the email address provided on the entry form. The potential winner will also be required to correctly answer a time-limited skill-testing question to be eligible to receive the prize. If the question is answered incorrectly, the prize will be forfeited. If a selected potential winner cannot be contacted using the email supplied with the entry or is contacted and does not respond via email as directed within 5 days of attempted notification or refuses the prize or is ineligible to accept the prize, the prize will be forfeited and may be awarded to an alternate potential winner.
